Summary of Slovenian "Big Win" commitments

- 1. Promotion of regional cooperation to achieve transboundary sustainable management of the Balkan ecoregions
- 2. Providing technical assistance to the countries of the Dinaric Arc region
- 3. Increasing the protected area network in the Slovenian part of the Dinaric region for 2,5 percent
- 4. Development of transboundary cooperation between relevant protected areas

Summary of Slovenian "Big Win" commitments

- Promotion of new types of protected areas governance (private – public)
- 6. Linking protection of the Alpine Convention region with the Dinaric Arc Ecoregion
- 7. Researching further the vulnerability of karst hydrological systems
- 8. Awareness raising campaigns to demonstrate benefits of protected areas for local inhabitants
